Since 30 November 2019, everyone in the UK, who flies a model weighing more than 250g is, by law, required to have an Operator ID / Flyer ID. This can be obtained by registering and passing an online test for the Registration Competency **Certificate** and paying a fee.

As a responsibly run club that is affiliated to the British Model Flying Association (BMFA), Ivel MAC will only accept membership application from people who fulfil the requirements by having:

1. BMFA Achievement Certification, (and therefore have an exemption for taking the test, but you will still need to pay the registration fee)

- 2. Already registered, and passed either the CAA or BMFA Registration Competency Certificate.
 - a. If you take the BMFA test, you will be issued with an online Certificate in PDF form, which will be needed when you join our club, after which, the BMFA will issue an Operator ID and Flyer ID.
 - b. If you take the CAA test, after successful completion you will be issued with an Operator ID and Flyer ID.

If you are new to the hobby (it is actually a registered sport) we recommend that you contact the club and discuss the situation, requirements for the test and also discuss suitable models and equipment Radio etc.

- Membership period is 1 Jan 24 31 Dec 24. 1.
- 2. All new members are subject to a 6-month probationary period.
